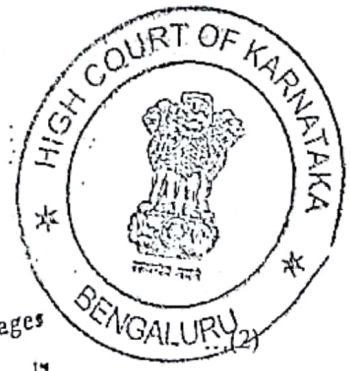

Learned Senior counsel for the petitioners submitted that
in exercise of powers under Section 14(2) read with Section 26
of the National Commission for Homeopathy Act, 2020
(hereinafter referred to as 'the Act' for short), the regulations
have not been framed. Therefore, it is further submitted that
the regulations under the old Act namely Homeopathy Central
Council Act, 1973 applies to the fact situation of the case in
view of Section 59(2) of the Act. It is also submitted that on
previous occasions, various Division Benches of this Court had
passed interim orders on 11.10.2018 in W.P.No.41486-
534/2018 as well as 20.09.2019 in W.P.No.41486-534/2018
and on 25.02.2021 in W.P.No.100650/2021. It is also pointed
